## **CHILD CARE Guidance for Suspected or Confirmed COVID-19 Cases**

CHILD CARE duidance for Suspected of Confirmed COVID-19 Cases		
Scenario	Immediate Action	Follow Up
COVID-19 Symptoms  (e.g., fever, cough, loss of taste or smell, difficulty breathing)	Send home and advise contact with primary care provider for recommendations regarding need for testing. If not available through their primary care provider, testing is available through CCHS. If COVID-19 ruled out by primary care provider or negative test result, can return 24 hours after symptoms resolve.  If symptomatic and a known contact to a positive case, refer to the "Contact to COVID19 – Symptomatic" instructions below.	Cohort may remain open.  Notification of cohort in this scenario is at the discretion of each institution and not required by CDPH or CCHS.  No notification of CCHS required.
*Testing recommended no sooner than 7-10 days after exposure to a COVID-19 positive individual.	If no symptoms <b>and</b> not a contact to a COVID19 positive individual, may return to cohort.  If symptoms present, may return to cohort after 24 hours of symptom improvement and no fever (without the use of fever-reducing medication).	Cohort may remain open.  Notification of cohort in this scenario is at the discretion of each institution and not required by CDPH or CCHS.  No notification of CCHS required.
Positive COVID-19 Individuals with a laboratory confirmed COVID-19 PCR or Antigen test result.	<ul> <li>Must isolate at home. The timelines for returning are:</li> <li>With symptoms: May return after at least 10 days have passed since symptoms onset, at least 24 hours have passed since resolution of fever without the use of fever-reducing medications, and symptoms are improving.</li> <li>Without symptoms: May return after 10 days have passed since the date of positive COVID-19 test. If symptoms develop during isolation period, may return after at least 10 days passed since symptom onset, at least 24 hours have passed since resolution of fever without the use of fever-reducing medications, and symptoms are improving.</li> </ul>	CCHS Notification:  1. Notify CCHS using:



	No repeat testing required to return to cohort.  Next Steps:  1. Identify close contacts and proceed with case notification.  a. CCHS has a sample script for case interviews and sample template notification letters for students and staff who have been exposed.  2. Quarantine and exclude exposed contacts for 10 days after the last date the case was present at cohort while infectious.  3. Recommend testing of contacts, but testing negative will not shorten 10 day quarantine.	Cleaning Instructions: If notified of a positive COVID- 19 case within previous 24 hours – close, clean and disinfect the affected areas concentrating on all high touch surfaces and areas where positive case(s) spent their time. Classroom and other affected areas may reopen after disinfection contact time.
Contact to COVID- 19 No symptoms	Must <u>quarantine at home</u> for 10 days after the last known close contact with the positive case, whether tested or untested. Testing is highly recommended, but a negative test does not release one from quarantine. Symptoms can develop even after testing negative within 10 days after exposure, so strict adherence to quarantine is required. Testing is recommended no sooner than 7-10 days after exposure to a COVID-19 positive individual.	No notification of CCHS required.
Contact to COVID- 19 Symptomatic	Must <u>quarantine at home</u> for 10 days after the last known close contact with the positive case. Testing is highly recommended and if test returns positive, refer to actions and follow up for "Positive COVID-19." If tests negative, must complete 10 day quarantine.	No notification of CCHS required unless positive test result.
